- [43. Notwithstanding anything contained in this Notification, all cases pending in a Labour Court immediately before the issuance of this notification shall continue to be proceeded with in the Courts where these cases are pending.

NATIONAL BOARD OF REVENUE

NOTIFICATION

Dacca, the 25th June, 1980

No. S.R.O. 202-L/80.—In exercise of the powers conferred by section 59 of the Income-tax Act, 1922 (XI of 1922), the National Board of Revenue is pleased to make the following further amendments in the Income-tax Rules, the same having been previously published as required by sub-section (4) of the said section, namely:—

Amendments

In the aforeaid Rules, in rule 45, in sub-rule (4),-

- (1) in clause (a), after the words "any of the sub-clauses to the said clause", the words and the commas "and, unless he is a person qualified under sub-clause (d) of the said clause, his application shall be accompanied by a fee of Taka one hundred only" shall be added;
- (2) in clause (c), after the words "it shall" the commas and the words ", subject to the provisions of clause (d),", shall be inserted; and
- (3) after clause (c), amended as aforesaid, the following new clause shall be added, namely:—
 - (d) All persons qualified under sub-clauses (a), (b) and (c) of the said clause shall be required to pass a viva voce examination to be conducted by the National Board of Revenue in such manner and on such dates as may be decided by it.".

(Income tax) NOTIFICATION

Dacca, the 25th June, 1980

No. S.R.O. 203-L/80.—(1) In exercise of the powers conferred by subsection (1) of section 60 of the Income-tax Act, 1922 (XI of 1922), the Government is pleased to exempt, subject to the limits and conditions specified below, from the tax payable under the said Act so much of the total income of an assessee not being a company, as is invested by him in the previous year in the purchase of Mutual Fund Certificates of the Investment Corporation of Bangladesh.

(2) The aggregate of any sums exempted under paragraph (1) shall not, together with any sums exempted from tax under the first proviso to subsection (1) of section 7, sub-sections (1) and (2A) of section 15, section 15AA, section 15C, section 15CC and section 15F and any sum exempted under sub-section (1) of section 58F of the aforesaid Act, exceed thirty per cent of the total income of the assessee or thirty thousand Taka, whichever is the less.
