


No. S. R. O. 208-L/81/S-VI/3R-3/81/175.—In exercise of the powers conferred by section 86 of the Local Government Ordinance, 1976 (XC of 1976), the Government is pleased to make the following amendments in the Swanirvar Gram Sarkars (Constitution and Administration) Rules. 1980, namely:—

In the aforesaid Rules,-

- (1) in rule 2,-
 - (i) after clause (a), the following new clause shall be inserted, namely:—
 - "(aa) "electoral persons" means such persons whose names appear in the electoral roll, so far it relates to the Gram concerned for the time being in force for the purpose of election of members of Parliament;"; and
 - (ii) for clause (c) the following shall be substituted, namely:-
 - "(c) "Gram Shava" means a Gram Shava constituted under sub-rule
 (2) of rule 4 which shall consist of all electoral persons;";

- "5A. Division or amalgamation of gram.—(1) A gram may be divided into two or more grams or a gram may be amalgamated with one or more other grams if the area constituting the proposed gram consequent upon the division or amalgamation is considered to be compact and its population shall consist of not less than three hundred electoral persons.
 - (2) No proposal for division or amalgamation of a gram under sub-rule (1) shall be considered unless a requisition in this behalf is submitted to the Circle Officer signed by majority of the electoral persons of the gram or, as the case may be, the grams concerned.
 - (3) On receipt of a requisition under sub-rule (2) the Circle Officer shall, within a period of fifteen days from the date of receipt of the requisition, convene, in such place within the territorial limits of the gram or grams concerned as the Circle Officer decides in this behalf, a meeting of the Gram Shava or Gram Shavas concerned for the purpose of taking a decision in this behalf.
 - (4) If the meeting decides in favour of the proposal by a majority support, expressed in the manner as the Circle Officer approves he shall, declare accordingly and in doing so he will follow the provisions of sub-rule (1) of rule 4.
 - (5) On the declaration of a gram in accordance with 'the provision of this rule, the existing Swanirvar Gram Sarkar of the gram or grams concerned shall stand dissolved and a Swanirvar Gram Sarkar shall, in accordance with the provisions of rule 5, be constituted:

Provided that notwithstanding the declaration of a gram under this rule, the Swanirvar Gram Sarkar which immediately before such declaration exercised function shall, until such sarkar is constituted for the gram declared under this rule, continue to exercise such function.";

- (3) in rule 6 after sub-rule (2), the following new sub-rule shall be added. namely:—
 - "(3) Notwithstanding anything contained in this rule, the term of office of a Swanirvar Gram Sarkar constituted under rule 5A shall be for the residue of the term of their predecessor."; and
 - (4) in rule 23, for the full-stop at the end a colon shall be substituted and thereafter the following proviso shall be added, namely:—

"Provided that in case the meeting is not called by the Gram Pradhan within the aforesaid period, the Circle Officer shall, on his own motion or on the basis of requisition in this behalf by any person of the gram, call the meeting of the Gram Shava for the purpose at a place within the gram and at a time and date fixed by him, which shall be presided over by him or by an officer authorised by him in this behalf and the decision taken in the meeting shall be deemed to be the decision of the Gram Shava and shall be acted upon accordingly."
