No. S.R.O. 265-L/80/577/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to make the following amendments in its Notification No. S.R.O. 153-L/79/485/Cus, dated the 2nd June, 1979, namely:—

In the aforesaid Notification, in the Table—

- (a) for Heading number 1 in column (1) and the entries relating thereto in columns (2) and (3) the following shall be substituted and shall be deemed to have been so substituted on the 7th July, 1980, namely:—

"Long jute, raw		
(i) Grades 'A', 'B'	10%	of the amount which would represent the value for export purposes, where no export duty chargeable thereon.
(ii) Grades 'D' and 'E'	5%	of the amount which would represent the value for export purposes, where no export duty chargeable thereon.
(iii) Jute cuttings ..	5%	of the amount which would represent the value for export purposes, where no export duty chargeable thereon.
(iv) Other	5%	of the amount which would represent the value for export purposes, where no export duty chargeable thereon."

- (b) for Heading number 13 in column (1) and the entries relating thereto in columns (2) and column (3) the following shall be substituted, namely:—

"13. Wet blue (semi finished) leather ..	5%	of the amount which would represent the value for export purposes, where no export duty chargeable thereon."
