NOTIFICATION

Dacca, the 17th June 1982

No. S.R.O. 210-L/82/721/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), and sub-section (1) of section 7 of the Sales Tax Act, 1951 (III of 1951), the Government is pleased to make the following further amendments in this Division's Notification No. S.R.O. 111-L/81/632/Cus., dated the 9th April, 1981, namely:—

In the aforesaid Notification,—

- (1) in the first paragraph, in the conditions, in sub-paragraph (i),—  
(i) in clause (a), after the semi-colon at the end, the word "and" shall be added;

- (ii) for clause (b) the following shall be *substituted*, namely:—
- “(b) the spare parts of, or the articles for use with, machinery, whether or not covered by the Tariff Headings enumerated in Table I, valued up to 10% of the value of the machinery and imported along with such machinery, provided that such spare parts or articles are identifiable for use with machinery and have been given for that purpose some special shape, size or quality;”;
- (iii) clause (c) shall be *omitted*; and
- (2) in paragraph 2, in sub-paragraph (i), *after* the word “goods” at the end, the words “or services” shall be *added*;
- (3) in Table II,
- (a) in Part A,—
- (i) in clause (a), the words “and Abhaynagar of the Jessore district” shall be *omitted*;
- (ii) for clause (b) the following shall be *substituted*, namely:—
- “(b) Less Developed Area:  
The whole of Bangladesh except the areas falling under developed area . . . . . 2½% *ad val.*”; and
- (iii) clause (c) shall be *omitted*;
- (b) in Part B,—
- (i) against clause (a) in the first column, for the figure and words “5% *ad val.*” the figure and words “2½% *ad val.*” shall be *substituted*;
- (ii) in clause (b), *after* the word “Director-General”, the words “or Deputy Director-General” shall be *inserted*;
- (iii) in clause (c),—
- (A) *after* the words “its manufactured products”, the words “or services” shall be *inserted*;
- (B) *after* the word “Director-General”, the words “or Deputy Director-General” shall be *inserted*; and
- (C) *after* the word “products” appearing at the end, the words “or services” shall be *added*; and
- (4) in Annex-I, for the words “Director General” the words “Director-General or Deputy Director-General” shall be *substituted*.
2. This amendment shall take effect on and from the 1st day of June, 1982.
