No. 660-Pub.—The following Ordinance made by the President of the People's Republic of Bangladesh, on the 6th July, 1976, is hereby published for general information :—

**THE PUBLIC INVESTMENTS (FINANCIAL SAFEGUARDS)
(AMENDMENT) ORDINANCE, 1976**

AN
ORDINANCE

further to amend the Public Investments (Financial Safeguards) Ordinance, 1960.

WHEREAS it is expedient further to amend the Public Investments (Financial Safeguards) Ordinance, 1960 (Ord. No. XLVI of 1960), for the purposes hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamations of the 20th August, 1975, and the 8th November, 1975, and in exercise of all powers enabling him in that behalf, the President is pleased to make and promulgate the following Ordinance :—

1. **Short title.**—This Ordinance may be called the Public Investments (Financial Safeguards) (Amendment) Ordinance, 1976.

2. **Amendment of Ord. No. XLVI of 1960.**—In the Public Investments (Financial Safeguards) Ordinance, 1960 (Ord. No. XLVI of 1960), hereinafter referred to as the said Ordinance, throughout the Ordinance, for the words “appropriate Government” the word “Government” shall be *substituted*.

3. **Omission of section 2, Ord. XLVI of 1960.**—In the said Ordinance, section 2 shall be *omitted*.

4. **Amendment of section 3, Ord. XLVI of 1960.**—In the said Ordinance, in section 3, in sub-section (1), for the words “Central or Provincial law” the words “Bangladesh law” shall be *substituted*.

5. **Amendment of section 6, Ord. XLVI of 1960.**—In the said Ordinance, in section 6, for the words “ten thousand rupees” the words “Taka fifty thousand” shall be *substituted*.

Whereas it appears to me that (1) S.-I. Asadul Huq of Dacca Metropolitan Police, Dacca, formerly D.I.O., Thakurgaon P.S., Dist. Dinajpur and (2) S.-I. Mozammel Hossain of Village Gobra, P.S. Kumarkhali, Dist. Kushtia, formerly Officer-in-charge, Thakurgon P.S., Dist. Dinajpur, are wanted in connection with the above case under Regulation 11 of MLR 1/75.

And whereas I have reasons to believe that the said accused are absconding and are concealing themselves so that they cannot be arrested and produced before this Court for trial.

Now, therefore, in exercise of the powers vested in me under Regulation 3(7) of M.L.R. 1/75, I, BA-10244 Lt. Col. Muhammad Azizur Rahman, Chairman, Special Martial Law Court No. V, Rangpur, do hereby direct the aforesaid accused persons to appear before me in my Court on 19th July, 1976, at 10 a.m.

It is further ordered that if the said persons fail to comply with the above direction, they would be tried in their absence and their property would be liable to be forfeited to the Government.

No. S.R.O. 225-L/76/P14M-18/76(1)MHA(Police-I).—In exercise of the powers conferred by section 109 of the Dacca Metropolitan Police Ordinance, 1976 (Ord. No. III of 1976), the Government is pleased to make the following rules, namely :—

1. **Short title.**—These rules may be called the Dacca Metropolitan Police (Notice of Penalty) Rules, 1976.

2. **Form of notice under section 102.**—(1) A notice which may be given or affixed on the body of the vehicle under section 102 of the Dacca Metropolitan Police Ordinance, 1976 (Ord. No. III of 1976), shall be in the form annexed to these rules.

(2) The notice referred to in sub-rule (1) shall be prepared in triplicate, the original copy of which shall be given to the person who has committed the offence or, when such person is not available, affixed on the body of the vehicle in respect of which the offence has been committed, and of the two other copies, one shall be forwarded to the Magistrate before whom the offender is directed to appear and pay the penalty and the other shall be retained by the police-officer who gave the notice.
