AN
ORDINANCE

to amend the Irrigation (Imposition of Water Rate) Ordinance, 1963.

WHEREAS it is expedient to amend the Irrigation (Imposition of Water Rate) Ordinance, 1963 (E.P. Ordinance No. VII of 1963) for the purpose hereinafter appearing;

NOW, THEREFORE, in pursuance of the Proclamations of the 20th August, 1975, and 8th November, 1975, and in exercise of all powers enabling him in that behalf, the President is pleased to make and promulgate the following Ordinance:—

1. **Short title and commencement.**—(1) This Ordinance may be called the Irrigation (Imposition of Water Rate) (Amendment) Ordinance, 1976.

(2) It shall come into force at once and it shall be deemed to have taken effect on 10th May, 1976.

2. **Amendment of Section 4, E.P. Ord. No. VII of 1963.**—In the Irrigation (Imposition of Water Rate) Ordinance, 1963 (E. P. Ordinance No. VII of 1963), in sub-section (1) of section 4, the words “at such rate as may be determined under sections 7 and 8 of this Ordinance” shall be *omitted*.

3. This arrangement will continue till 31st August, 1976.

4. This supersedes this Division's Resolution No. ED/AI-224/75-1012, dated the 30th December, 1975 and Order No. ED/AI-224/75-8, dated the 1st January, 1976.
