

No. S.R.O. 233-L/81/S-XIII/IR-7/80/452.—The following further amendments which the Government proposed to make in the Co-operative Societies Rules, 1942, in exercise of the powers conferred by section 140 of the Co-operative Societies Act, 1940 (Bengal Act XXI of 1940), is hereby published, as required by sub-section (i) of the said section for information of all persons likely to be affected thereby, and notice is hereby given that the draft will be taken into consideration on or after 28th Juty 1981. Any objection or suggestion with respect to the said draft which may be received by the undersigned before the date specified will be duly considered by the Government.

Draft Amendment

In the Co-operative Societies Rules, 1942, in rule 7, in sub-rule (1), for the colon at the end a full-stop shall be substituted and the words, commas and full-stop "Provided that the Registrar may, for reason to be recorded in writing, permit a society to be registered without being required to remain on probation as provided in this rule," shall be omitted.

Draft Amendments

In the aforesaid Rules,-

- (a) in rule 2, in sub-rule (3),-
 - (i) in clause (iii), for the words "five members are" the words "ten members are primary" shall be substituted; and
 - (ii) for clause (XI) the following shall be substituted, namely-
 - (XI) "national society" means a co-operative society the primary object of which is to facilitate the operation of other central societies and which has other central societies as its members;" and
- (b) in rule 7, for sub-rule (2) the following shall be substituted, namely-
 - "(2) no national society or central society shall be registered unless it has in the case of a national society, at least ten central societies, and in the case of a central society, at least ten primary societies, as members:

Provided that the provision of this sub-rule shall not apply to the Comilla Kotwali Thana Central Co-operative Association Limited, the Bangladesh Milk Producers Co-operative Union Limited, the Bangladesh Auto-Rickshaw Chalak Samabaya Samity Limited, the Bangladesh Gana-Paribahan Chalak Samabaya Samity Limited and the Bangladesh Auto-Tempo Chalak Samabaya Samity Limited.".
