NOTIFICATION

Dacca, the 20th August, 1979.

No. S.R.O. 233-L/79.—Whereas the Government is of opinion that lands under cultivation within the mouzas specified in the Schedule below, under Police Station Alamdanga in the district of Kushtia, are benefited or are likely to be benefited by irrigation water supplied or regulated by the Bangladesh Water Development Board;

Now, therefore, in exercise of powers conferred by sub-section (1) of section 4 of the Irrigation (Imposition of Water Rate) Ordinance, 1963 (E. P. Ord. VII of 1963), the Government is pleased to declare its intention to impose a water rate in the aforesaid Scheduled mouzas at the rate of three per cent of the gross increased benefits accruing to the owners or occupiers as a result of the supply or regulation of irrigation water to such lands.

Any person interested in any land likely to be affected by the imposition of the water rate may, within a period of one month from the date of publication of this Notification in the Official Gazette, prefer objections to the Government to the intended imposition of water rate, or the rate at which
