## NOTIFICATION

Dacca, the 19th September, 1979.

No. 247-L/79.—In exercise of the powers conferred by section 248 of the Companies Act, 1913 (VII of 1913), and in supersession of the Notification No. 3192-Com., dated the 2nd December 1926, the Government is pleased to specify the situation of the office of the registrar, the duties of, and the fees payable to, the registrar, namely:—

1. The office of the registrar shall be situated in Dacca.
2. (1) The duties of the assistant registrar shall be performed subject to the executive control of the registrar.  
(2) The office shall be open for business (Sundays and authorised holidays excepted) between 7-30 a.m. and 2 p.m. except Fridays when it shall remain open between 7-30 a.m. and 12-30 p.m., or between such other hours as may be specified by the Government from time to time.
3. On receipt of every document required by the Act to be filed or registered in his office, the registrar shall examine it, and if it is found to be defective, incorrect, untrue or inconsistent with, or incomplete in any of the particulars required by the law, he shall return it to the party applying for registration, or to the Company concerned, for the rectification or completion; and until such rectifications be made or documents completed, he shall not register or file the documents nor shall he grant a certificate in respect thereof.
4. The registrar shall not permit members of the public to make copies of any documents, but only to make such extracts from the registers, returns, records or documents as may, in the opinion of the registrar, properly be made.
5. No document or fact in respect of which a fee is legally payable shall be filed, registered or recorded by the registrar until the said fee has been received; and the registrar shall, pending the receipt of such fee, act in the same way as if no such documents or fact had been tendered for filing, registration or record.
6. The registrar may institute such enquiries or make such investigations in respect of any matter as may be necessary for proper performance of his duties and the administration of the Act; and, for achieving the said purposes, he or any officers authorised or appointed by him including the inspectors of companies may, if necessary, enter into the office premises of any company for an on-the-spot investigations or enquiry and the registrar may also institute or cause to institute prosecutions under the Act for default on the part of the company and its officers in furnishing such returns, documents, notices and information as the law requires them to furnish and for non-compliance with the provisions of the Act for which penalties are provided by the Act.
7. The registrar shall prepare at the close of each financial year a brief report on the working of the Act together with such schedules as may be specified by the Government from time to time.

8. Any person may inspect the documents kept by the registrar on payment of the fees specified in Table 'B' of the First Schedule and any person may require copies of certificate of incorporation, certificate of commencement of business, copy or extract of any other documents or any part of any other documents to be certified by the registrar on payment of the fees specified under item 'IV—General' in Table 'B' of the First Schedule to the Act.
