NOTIFICATION

Dhaka, the 5th July 1983

No. S.R.O. 247-L/83.—In exercise of the powers conferred by clause (a) of sub-section (1) of section 4 of the Ports Act, 1908 (XV of 1908), read with sub-section (2) of that section, the Government is pleased to extend the said Act to the Ports of Aricha, Nagarbari, Daulatdia and Kazirhat and to define the limits of the said Ports as under:—

Limits of the ports

I. Aricha, District Dhaka

- (a) To the North—A line drawn east and west at latitude $23^{\circ}-51'-0''N$.
- (b) To the South—A line drawn east and west at latitude $23^{\circ}-49'-0''N$.
- (c) To the East—Up to 50 yards beyond the high water mark at ordinary spring tides from the east bank of river Jamuna.
- (d) To the West—Up to 100 yards of river Jamuna from the east bank of the said river as it runs between the above prescribed north and south limits.

II. Nagarbari, District Pabna

- (a) To the North—A line drawn east and west at latitude $23^{\circ}-58'-0''N$.
- (b) To the South—A line drawn east and west at latitude $23^{\circ}-56'-0''N$.

- (c) To the West—Up to 50 yards beyond the high water mark at ordinary spring tides from the west bank of river Jamuna.
- (d) To the East—Up to 100 yards of river Jamuna from the west bank of the said river as it runs between above prescribed north and south limits.

III. Daulatdia, District Faridpur

- (a) To the North—A line drawn east and west at latitude $23^{\circ}-47'-0''N$.
- (b) To the South—A line drawn east and west at latitude $23^{\circ}-45'-30''N$.
- (c) To the West—Up to 50 yards beyond the high water mark at ordinary spring tides from the west bank of river Jamuna.
- (d) To the East—Up to 100 yards of river Jamuna from the west bank of the said river as it runs between above prescribed north and south limits.

IV Kazirhat, District Pabna

- (a) To the East—A line drawn north and south at longitude $89^{\circ}-40'-30''E$.
- (b) To the West—A line drawn north and south at longitude $89^{\circ}-39'-30''E$.
- (c) To the North—Up to 50 yards beyond the high water mark at ordinary spring tides from the north bank of river Padma.
- (d) To the South—Up to 100 yards of river Padma from the north bank of the said river as it runs between above prescribed east and west limits.

NOTIFICATIONS

Dhaka, the 5th July 1983

No. S.R.O. 248-L/83.—In exercise of the powers conferred by sub-section (1) of section 60 of the Income-tax Act, 1922 (XI of 1922), the Government is pleased to exempt from the income-tax so much of the income of a holder of prize winning Bonds as is derived by him as prize money from Prize Bonds issued by the Government.

2. This notification shall be deemed to have taken effect on and from the 1st July, 1975.

No. S.R.O. 249-L/83.—In exercise of the powers conferred by sub-section (1) of section 60 of the Income-tax Act, 1922 (XI of 1922), the Government is pleased to exempt the expatriate consultants of the Trade and Industrial Policy (TIP) Reform Programme Project from payment of tax on so much of income as is received by them in Bangladesh out of fulfilment of their functions under the contract between the Government of the People's Republic of Bangladesh and the Harvard College for rendering consultancy services to the Project.

 section 409/109 B.P.C. and MLR 11/9 of Regulation 1/82.

Whereas it has been appeared to me that the accused Emdad Hossain Khandaker, *ex-Manager*, Pubali Bank, Science Laboratory Branch, Dhaka, son of late Abdul Aziz Khandaker of 26/A, Cantonment Market Area, Dhaka, is required for the purpose of trial in the Special Martial Law Court No. 1, Dhaka;

And whereas the court has reason to believe that the said accused Emdad Hossain Khandaker in the case abovementioned, is absconding or concealing himself to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of the powers conferred by regulation 2 (11) of the Martial Law Regulation No. I of 1982, this Special Martial Law Court No. 1, Dhaka, do hereby direct the aforesaid accused person to appear in this court on 26th July 1983 at 9-30 a.m. in Case No. 42/82, failing which he will be tried *in absentia* and his properties, both movable and immovable, may be forfeited to the Government.
