- (9) In page 2552, in Article 14, in paragraph (1), in sub-paragraph (a), in line 2, *insert* a comma *after* the word "case",
- (10) In the same page, in Article 14, in paragraph (2), in line 3, *for* the word "lowyers" *read* "lawyers",
- (11) In page 2553, in Article 16, in paragraph (2), in line 3, *omit* the commas *after* the figure "14" and the word "taxed",
- (12) In page 2554, in Article 19, in paragraph (1), in sub-paragraph (b), in line 2, *for* the word "practise" *read* "practice",
- (13) In page 2555, in Article 19, in paragraph (1), in sub-paragraph (iii), in line 5, *for* the word "constitute" *read* "constitutes",
- (14) In page 2557, in Article 22, in paragraph (2), in sub-paragraph (a), in line 7, *omit* the comma *before* the word "dated",
- (15) In the same page, in Article 22, in paragraph (2), in sub-paragraph (b), in line 5, *after* the word "character", *for* the colon *substitute* a fullstop,
- (16) In the same page, in Article 22, in paragraph (3), in line 2, *before* the word "payable" *insert* the word "tax".
