1. In Annex 1 (Priority List I)-

(a) after Sl. No. 67 (Chemical Group), the following industry shall be inserted:

"67A. Rigid P.V.C. Granuls".

(b) after Sl. No. 134 (Engineering Group), the following industry shall be inserted:

"134A. Gas and Electrical Appliances".

 In Annex 2 (Chemical Group), after Sl. No. 87, the following shall be inserted under cols. 1, 2 and 3—
