(Customs)

NOTIFICATION

Dacca, the 18th August, 1980

No. S.R.O. 269-L/80/579/Cus.—In exercise of the powers conferred by section 219 of the Customs Act, 1969 (IV of 1969), read with item 17 of the Third Schedule thereof, the National Board of Revenue is pleased to make the following amendments in the Passengers (Non-tourists) Baggage (Import) Rules, 1980, namely:—

In the aforesaid Rules,—

- (1) in rule 2, in clause (b), the words and commas "Video Cassette recorders, Video Cassette Tapes," shall be omitted;
- (2) in rule 4,
  - (a) for the words "earning foreign exchange abroad and arriving" the words "arriving from abroad" shall be substituted;
  - (b) in the Table, in column 3, for the entries against serial numbers 3 and 4, the entries "Taka ten thousand only" and "Taka twelve thousand and five hundred only" shall respectively be substituted;

(c) in the proviso—

(i) in paragraph (ii), after clause (b), the following new clause (c) shall be added, namely:—

“(c) notwithstanding anything contained in column 3 of the table, a passenger returning after a stay abroad for a period exceeding six months may import, once in a year, a Video Cassette Recorder on payment of full customs duty and taxes. The Video Cassette Tapes up to a reasonable number, however, may be imported within the value ceiling of column 3 of the table, on payment of full customs duty and taxes and subject to other rules and regulations laid down by the Government.”

(ii) in paragraph (iii), for the words “three years”, the words “one year” shall be substituted;

(iii) clause (vi) shall be omitted;

(3) for rule 6 the following shall be substituted, namely:—

“6. Aircrews of Bangladesh Biman coming from foreign airports after a continuous duty exceeding forty eight hours shall be allowed to import free of duty articles of personal or household goods of the aggregate value not exceeding Taka one hundred and fifty only.”;

(4) in rule 9, after the word “concerned” at the end, the words and comma “and beyond that period, by the Collector of Customs” shall be added;

(5) in the Schedule, in paragraph (3), for the words “Taka five hundred” and “Taka one thousand” the words “Taka seven hundred and fifty” and “Taka fifteen hundred” shall respectively be substituted.
