O. 270-L/81/S-XIII/IR-7/80/561.**—In exercise of powers conferred by section 140 of the Co-operative Societies Act, 1940 (Bengal Act XXI of 1940), the Government is pleased to make the following amendment in the Co-operative Societies Rules, 1942, the same having been previously published, as required by sub-section (i) of that section in the *Bangladesh Gazette*, dated July 6, 1981:

**Amendments**

In the Co-operative Societies Rules, 1942, in rule 7, in sub-rule (i), for the colon at the end a full-stop shall be *substituted* and the words, commas and full-stop "Provided that the Registrar, may, for reason to be recorded in writing, permit a society to be registered without being required to remain on probation as provided in this rule." shall be *omitted*.

**No. S. R. O. 271-L/81/S-XIII/IR-9/80/562.**—In exercise of powers conferred by section 140 of the Co-operative Societies Act, 1940 (Bengal Act XXI of 1940), the Government is pleased to make the following amendment in the Co-operative Societies Rules, 1942, the same having been previously published,

as required by sub-section (i) of that section in the *Bangladesh Gazette*, dated July 6, 1981:

### Amendments

In the aforesaid Rules,—

(a) in rule 2, in sub-rule (3),—

(i) in clause (iii) for the words “five members are” the words “ten members are primary” shall be substituted; and

(ii) for clause (XI) the following shall be substituted, namely—

(XI) “national society” means a co-operative society the primary object of which is to facilitate the operation of other central societies as its members;” and

(b) in rule 7, for sub-rule (2) the following shall be substituted, namely—

“(2) no national society or central society shall be registered unless it has in the case of a national society, at least ten central societies, and in the case of a central society, at least ten primary societies, as members :

Provided that the provision of this sub-rule shall not apply to the Comilla Kotwali Thana Central Co-operative Association Limited, the Bangladesh Milk Producers Co-operative Union Limited, the Bangladesh Auto-Rickshaw Chalak Samabaya Samity Limited, the Bangladesh Gana-Paribahan Chalak Samabaya Samity Limited and the Bangladesh Auto-Tempo Chalak Samabaya Samity Limited.”
