

No. S.R.O.285-L/81/665/Cus.—In exercise of the powers conferred by section 7 of the Sales Tax Act, 1951 (III of 1951), and section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to direct that the articles falling under the Tariff Headings of the First Schedule to the Customs Act, 1969,

specified in the Table below shall be exempt from the whole of the sales tax leviable thereon and from so much of the customs duties leviable thereon as is in excess of 15 per cent ad valorem:

Provided that it is established to the satisfaction of an officer of Customs not below the rank of an Assistant Collector of Customs that the articles are intended to be used for the purposes of agriculture including poultry-keeping and cannot ordinarily be used or shall not be used for any other purpose.

NOTIFICATION

Dacca, the 31st August, 1981

No. S.R.O.286-I./81/48-Excise.—In exercise of the powers conferred by sub-section (1) of section 12A of the Excises and Salt Act, 1944 (I of 1944), the Government is pleased to exempt the locally manufactured PVC pipes and fittings falling under item No. 05·01 of the First Schedule to the said Act and supplied to an organisation after a successful bidding in the international tender the payment of which shall be received in foreign currency, from the whole of the excise dury leviable thereon subject to the following conditions, namely:—

- (a) that the manufacturer shall immediately inform the fact of the acceptance of his bid by the proper authority in the international tender mentioning the quality, quantity and value of the excisable goods alongwith the copy of the tender notice or copy of the bid and other papers to the concerned Collector of Customs and Excise showing full arrangements for the delivery of the goods and the payments as agreed upon; and
- (b) that the manufacturer shall furnish an undertaking to the concerned Collector of Customs and Excise to the effect that he shall be liable to pay the excise duty on the goods so delivered and, in addition, to any legal action in case of his failure to produce, within one month of his completion of delivery, a certificate from the Bangladesh Bank showing full receipt of the bid amount in foreign exchange.
