Dacca, the 25th August, 1976.

No. S.R.O. 290-L/76/17-Excise.—In exercise of the powers conferred by section 37 of the Excises and Salt Act, 1944 (I of 1944), the National Board of Revenue is pleased to make the following further amendment in the Excises and Salt Rules, 1944, namely :

In the aforesaid Rules, in rule 2, *for* clause (ii), the following shall be substituted, namely :—

“(ii) “Collector” means—

- (a) in the Commissioner's Divisions of Dacca and Rajshahi—the Collector of Excise, Dacca;
- (b) in the Commissioner's Division of Chittagong—the Collector of Excise, Chittagong; and
- (c) in the Commissioner's Division of Khulna—the Collector of Excise, Khulna,

and includes any officer specially authorised under rule 4 or 5 to exercise throughout Bangladesh or any specified area therein, all or any of the powers of a Collector under these rules;”.
