

No. S. R. O. 291-L/82/LIWVI/7(22)/82.—In exercise of the powers conferred by section 5 of the Factories Act, 1965 (E.P. Act IV of 1965), the Government is pleased to exempt all Wheat Crushing Mills from the provision of section 51 of the said Act for a period of six months in the public interest.

No. S. R. O. 292-L/82/LIWVI/7(22)/82.—In exercise of the powers conferred by sub-section (1) of section 3 of the Shops and Establishments Act, 1965 (E.P. Act VII of 1965), the Government is pleased to suspend the operation of section 5 of the aforesaid Act in respect of all Rice Mills, Flour Mills, Wheat Crushing Mills and all establishments dealing in rice and wheat including distribution and transportation of foodgrains for a period of three months in the public interest.
