

#### Dhaka, the 27th July 1983

No. S.R.O. 310-L/83/MVRT/IA-3/82.—In exercise of the powers conferred by section 70 of the Motor Vehicles Act, 1939 (IV of 1939), the Government is pleased to make the following further amendments in the Motor Vehicles Rules, 1940, the same having been previously published as required under sub-section (1) of section 133 of the said Act, namely:—

In the aforesaid Rules, in rule 114-

- (a) in sub-rule (a), for the words "a horn" the words "an electric horn or a bulb horn" shall be substituted;
- (b) in sub-rule (b), after the words "shall be fitted with"; the words "any air pressure horn or pneumatic horn or vacuum horn or shall be inserted;
- (c) in sub-rule (d), after the words "fitted with", the words "an electric horn or" shall be inserted;
- (d) after sub-rule (d), the following new sub-rule shall be inserted, namely :-
  - "(e) Any police officer of or above the rank of sub-Inspector of Police or Director of Road Transport Maintenance or any Inspector of Motor Vehicles may get removed any horns other than an electric horn or a bulb horn fitted to any motor vehicles and may dispose of the horns so removed in the manner he deems fit."

No. S. R. O. 314-L/83/798/Cus.—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969), the Government is pleased to make the following amendments in this Ministry's Notification No. S. R. O. 205-L/83/778/Cus., dated the 30th June, 1983, namely:—

In the aforesaid Notification, in the Table, -

- (1) after Tariff Heading No. 31.05 in column (1) and the entries relating thereto in columns (2) and (3), the following shall be inserted, namely:—
  - "32.05 Synthetic organic dyestuffs (including pigment dyestuffs); synthetic organic products of a kind used as luminophores; products of the kind known as optical bleaching agents, a substantive to the fibre; natural indigo

- (2) for Tariff Heading No. 32.09 in column (1) and the entries relating thereto in columns (2) and (3), the following shall be substituted, namely:—
  - "32.09 (i) Approved aircraft and helicopter paint imported by Bangladesh Biman, Flying Club or Government Departments: ... 2½% ad val.
  - (ii) Prepared water pigments of the kind used for finishing leather; and whitening for cleaning footwear in tablet form ... 50% ad val.".
- 2. This Notification shall take effect on and from the 30th June, 1983.
