

No. S.R.O. 303-L/82/69-Excise.—In exercise of the powers conferred by section 37 of the Excises and Salt Act, 1944 (1 of 1944), the National Board of Revenue is pleased to rescind its Notification No. S.R.O. 1-Excise/72, dated the 24th February, 1972.

No. S.R.O. 304-L/82/70-Excise.—In exercise of the powers conferred by section 37 of the Excises and Salt Act, 1944 (I of 1944), the National Board of Revenue is pleased to make the following further amendment in the Excises and Salt Rules, 1944, namely:—

In the aforesaid Rules, for rule 235 the following shall be substituted, namely:-

"235. Application of the revised procedure.—(1) Notwithstanding anything contained in rules 9, 47, 49, 52 and 185, the provisions of the rules in this Chapter shall apply, with regard to the matters hereinafter indicated,

to the following manufactured excisable goods, shown against their respective item Nos., specified in the First Schedule to the Excises and Salt Act, 1944 (I of 1944), namely:—

- 02:02 Sugar, all sorts;
- 02.05 Glucose and Dextrose;
- 03.01 Cement;
- 03.04 Petroleum gases and other gaseous hydrocarbons including natural gas and liquified petroleum gas;
- 03.15 Asphalt;
- 04.08 Starch (including Dextrin and other forms of modified starch), all sorts, manufactured mechanically with the aid of power, steam or gas;
- 04.09 Medicine or medicinal products, all sorts;
- 04.10 Antiseptic, disinfectant, insecticide, pesticide and germicide, all sorts, other than those used exclusively for agricultural purposes;
- 10.05 Stainless steel;
- 12.05 Welding Electrodes;
- 12.06 Oxygen, carbondioxide, nitrous oxide gas and acetylene (whether in dissolved condition or not).
- (2) In the case of any conflict between any provision contained in this Chapter and any provision contained elsewhere in these rules, the provision in this Chapter shall prevail.
- (3) Any matter not covered by the provision contained in this Chapter shall be governed by the appropriate provisions contained elsewhere in these rules."

NOTIFICATION
