NOTIFICATIONS

Dacca, the 16th November, 1979.

No S.R.O. 316-L/79.—In exercise of the powers conferred by subclause (xxiv) of clause (a) of section 2 of the Control of Essential Commodities Act, 1956 (E.P. Act I of 1956), the Government is pleased to declare ginger as an essential commodity for the purpose of the said Act.

No. S.R.O. 317-L/79.—In exercise of the powers conferred by section 3 of the Control of Essential Commodities Act, 1956 (E.P. Act I of 1956), the Government is pleased to make the following amendment in the Bangladesh Essential Commodities (Storage, Keeping and Disposal) Order, 1973, namely:—

In the aforesaid Order, after paragraph 13, the following new paragraph 13A shall be inserted, namely:—

- "13A. Storage, keeping and disposal of ginger.—(1) No wholesaler of ginger shall keep in his possession or under his control more than ten maunds of ginger at a time for more than seven days from the date of its acquisition by him.
- (2) No retailer of ginger shall keep in his possession or under his control more than two maunds of ginger at a time for more than seven days from the date of its acquisition by him.".

No. S.R.O. 318-L/79.—In exercise of the powers conferred by rule 17 of the Emergency Powers Rules 1975, the Government is pleased to make the following further amendments in the Essential Commodities Price and Distribution Control Order, 1975, namely:—

In the aforesaid Order,-

- (1) after clause 15, the following new clause 15A shall be inserted, namely:—
 - "15A. Notwithstanding anything contained in this Order, the Government may, by notification in the official Gazette, authorise the Mayor or any officer of a Municipal Corporation or the Chairman or any officer of a Paurashava to exercise within the jurisdiction of the Municipal Corporation or, as the case may be, Paurashava, all or any of the powers of the Controller General of Prices and Supplies under this Order in respect of such of the scheduled articles as may be specified therein."; and
- (2) in the Schedule, after item No. 25, the following new item 26 shall be added, namely:—

"26. Ginger.".

No. S.R.O. 319-L/79.—In exercise of the powers conferred by clause 15A of the Essential Commodities Price and Distribution Control Order, 1975, the Government is pleased to authorise the Mayor of the Dacca Municipal Corporation to exercise all the powers of the Controller General of Prices and Supplies in respect of onion and ginger within the Dacca Municipal Corporation.
