No. S.R.O. 320-L/82/S-V/3R-2/82/153.—In exercise of the powers conferred by section 146 of the Paurashava Ordinance, 1977 (Ord. XXVI of 1977), the Government is pleased to make the following further amendment in the Municipal Committee (Taxation) Rules, 1960, namely:—

In the aforesaid Rules, in rule 10, in the second proviso, for the full-stop at the end a colon shall be substituted and thereafter the following third proviso shall be added, namely:—

“Provided further that if the payment of any tax or rate in respect of any building and land is not made within the financial year for which it is due or within the time specified in the bill of demand, the Paurashava may impose a surcharge at the rate of 5 per cent of the demand defaulted during the previous financial year.”
