Dhaka, the 9th August 1983

No. S.R.O. 324.L/83/MVRT/3M-40/83.—In exercise of the powers conferred by section 70 of the Motor Vehicles Act, 1939 (IV of 1939), the Government is pleased to make the following further amendments in the Motor Vehicles Rules, 1940, the same having been previously published as required under sub-section (1) of section 133 of the said Act, namely:—

In the aforesaid Rules, after rule 162A, the following new rule shall be inserted, namely:

"162B. Painting of bodies of stage carriage.—All stage carriages plying within the areas of the city or towns mentioned in column 2 of the Table below, excluding those which are owned by the Government Departments, semi-autonomous bodies and public statutory corporations and used

exclusively for carrying their employees to and from the place of work and stage carriages owned by the Bangladesh Road Transport Corporation, shall be painted with colours specified in column 3 thereof."

THE TABLE

No		Colour by which stage carriages shall be painted.
1	Dhaka Metropolitan area including its suburbs.	Blue body with yellow top.
2	Chittagong Metropolitan Area	Green body with yellow top.
3	Khulna	Grey body with yellow top.
4	Rajshahi	Maroon body with yellow top.
