 - The application shall be accompanied by (a) the notice of Demand and the copy of the order appealed against, and (b) a copy of the chalan showing payment of application fee.
 - If the applicant is a company, a copy of the Balance Sheet as on the last day of the income year shall also be filed with the application.
 - 4. The form of application and verification thereof shall be signed
 - a. in the case of an individual, by the individual himself;
 - b. in the case of a company, by the principal officer thereof;
 - c. in the case of a firm, by a pertner;
 - d. in the case of any other association, by a member of the association; and
 - e. in the case of a Hindu undivided family, by the manager or karta.":
