No. S.R.O. 381-L/83/S-IX/SE-5/83/146.—In exercise of the powers conferred by sub-section (1) of section 3 of the Shops and Establishments Act, 1965 (E.P. Act VII of 1965), the Government is pleased to suspend the operation of the provisions of sub-section (1) of section 4 and clause (a) of section 10 of the said Act in respect of the offices of the Bangladesh Employers' Association and its member commercial establishments and in respect of those establishments which are members of the Metropolitan Chamber of Commerce and Industry, Dhaka for a period of one year, subject to the following conditions, namely:—

- (a) every worker employed in any such office or establishment shall be allowed two days' consecutive holidays in each week; and
- (b) every such worker shall be allowed an interval of at least half an hour during each working day for rest or meal.

This notification shall, in respect of the offices of the Bangladesh Employers' Association and its member commercial establishments, take effect from the date of expiry of the period specified in Notification No. S.R.O. 362-L/S-IX/SE-5/82, dated the 18th October, 1982.
