**No. S.R.O. 384-L/80/593/Cus.**—In exercise of the powers conferred by section 19 of the Customs Act, 1969 (IV of 1969) the Government is pleased to make the following further amendment in its Notification No. S.R.O. 244-L/78/447/D/Cus., dated the 18th September, 1978, namely :—

In the aforesaid Notification, in TABLE II, in Part A, under the heading "Priority Development Area", after the word "Patuakhali", the commas and words "Faridpur, Kushtia, Jessore, Sylhet, Noakhali, Mymensingh, Jamalpur; Tangail" shall be inserted.
