**No. S.R.O. 388-L/81.**—In exercise of the powers conferred by section 23 of the Trade Organisations Ordinance, 1961 (XLV of 1961), read with section 12 thereof, the Government is pleased to make the following rules, namely:—

1. **Short title.**—These rules may be called the Trade Organisations (Arbitration Tribunal) Rules, 1981.

2. **Definitions.**—In these rules, unless there is anything repugnant in the subject or context,—

- (a) "Chairman" means the Chairman of the Tribunal;
- (b) "Federation" means the Bangladesh Federation of Chambers of Commerce and Industry registered under the Act in pursuance of a licence;
- (c) "Ordinance" means the Trade Organizations Ordinance, 1961 (LXV of 1961); and
- (d) "Tribunal" means the Arbitration Tribunal constituted under sub-rule (1) of rule 3.

3. **Constitution of the Tribunal, etc.**—(1) The Federation shall, for the purpose of examining any reference made by any member of a trade organisation or by, or by any member of, any other trade organisation questioning the validity or propriety of any act or proceeding of such trade organisation or of the Executive Committee or other body thereof, or the constitution of, or election or appointment to, such Committee or body, constitute an Arbitration Tribunal which shall consist of not less than three and not more than five members to be appointed by it.

(2) The Federation shall appoint one of the members of the Tribunal to be the Chairman of the Tribunal. The Secretary-General of the Federation shall act as the Secretary of the Tribunal.

(3) The tenure of the Tribunal shall be the same as that of the Executive Committee of the Federation, and if, at any time, there be no Executive Committee of the Federation, the tenure of the Tribunal shall be such as the Government may determine.

(4) If a member of the Tribunal dies or neglects or refuses to act, or is, for any reason, unable to act, as a member of the Tribunal, the Federation shall appoint some other person in his place and the person so appointed shall act as a member of the Tribunal for the unspent period of the term of office of the member in whose place he has been appointed.



4. **Application to the Tribunal.**—(1) An application under section 12 of the Ordinance, referring a question relating to the validity or propriety of any act or proceeding of a registered trade organisation, or of the Executive Committee or body thereof, or the constitution of, or election or appointment to, such Committee or body, shall be made to the Secretary to the Tribunal and shall be accompanied by a fee of three thousand Taka payable by pay order or bank draft in favour of the Secretary of the Tribunal.

(2) An application made under sub-rule (1) shall be duly signed by the applicant and shall contain the full address of the applicant, specifying the points of dispute calling for arbitration.

(3) Upon receipt of an application under sub-rule (1) the Secretary of the Tribunal shall, with the approval of the Chairman, convene a meeting of the Tribunal within fifteen days of the receipt of the application and shall by notice in writing to be issued within seven days of the receipt of the application, require the applicant, respondent and any other person whose attendance may be necessary in connection with the arbitration to attend the meeting.

(4) A notice under sub-rule (3) issued by a special messenger or, by registered post shall be deemed to have duly issued.

5. **Procedure to be followed by the Tribunal.**—(1) The Tribunal shall inform the applicant, the respondent and other persons concerned of the place and time of the meeting of the Tribunal and of such procedure relating to the appearance of the parties to the reference and their lawyers as it may consider necessary. The Tribunal may also issue, from time to time, such instructions to the parties to the reference as it deems fit.

(2) The parties to the reference may appear either in person or by their authorised agents or through their lawyers and may produce such evidence as they desire to adduce in support of their respective cases and which the Tribunal considers to be relevant and necessary for the purpose of arriving at a decision or making an award.

(3) The parties to the reference shall submit to be examined by the Tribunal on oath or affirmation in relation to the matters in dispute and shall produce before the Tribunal all such books, papers, and other documents and records within their possession or power as may be required or called for, and do all other things the doing of which may, during the proceedings on the reference, be required, by the Tribunal.

(4) The Tribunal shall keep a record of the proceedings but such records need not be a verbatim record.

(5) Every party to a reference shall do all such acts as may be necessary to enable the Tribunal to arrive at a decision or to make just award and shall not wilfully do or cause or allow to be done any act or thing which may prevent the Tribunal from arriving at a decision or making an award on the reference or delay the arrival at such decision or making such award.

(6) The Tribunal shall sign a decision or award to be given by it and shall give a notice to that effect to the parties to the reference. The Tribunal shall supply on demand, a copy of the decision or award to each party to the reference.



6. **Disposal of the reference, etc.**—(1) An application under sub-rule (1) of rule 4 making a reference for arbitration shall be disposed of within one month of the first meeting of the Tribunal held in connection with the arbitration thereof.

(2) A decision or award to be given by the Tribunal shall be arrived at or made by the votes of the majority of its members present.
