NOTIFICATION

Dhaka, the 23rd October, 1983.

No. S.R.O. 386-L/83/MVRT/3M-24/83.—The following draft of certain further amendments to the Motor Vehicles Rules, 1940, which it is proposed to make, in exercise of the powers conferred by section 70 of the Motor Vehicles Act, 1939 (IV of 1939), is hereby published as required by sub-section (1) of section 133 of the said Act, for the information of all persons likely to be affected thereby and notice is hereby given that the draft will be taken into consideration on or after thirty days from the date of its publication in the official Gazette. Any objection or suggestion which may be received from any person in respect of the said draft within the period so specified will be taken into consideration by the Government.

#### Draft Amendments

In the aforesaid Rules,-

(a) in rule 2, after clause (b), the following new clause shall be inserted, namely:—

"(bb) "auto-tempo" means a motor cab with three wheels the unladen weight of which does not exceed 650 pounds, constructed or adapted or used to carry not more than six passengers excluding the drivers;";

(b) before rule 181-M, in the heading, after the word "RICKSHAWS", the words "AND AUTO-TEMPOS" shall be inserted;

- (c) after rule 181-M, the following new rule shall be inserted, namely:-
  - "181-N. Application of rule 181-M to auto-tempo.—The provisions of rule 181-M shall, *Mutatis Mutandis*, apply to auto-tempo subject to the following modifications, namely:—
    - (1) in sub-rule (5), for the words "nine feet six inches" the words "eight feet six inches" shall be substituted;
    - (2) in sub-rule (6), for the words "five feet six inches" the words "five feet ten inches" shall be substituted;
    - (3) in sub-rule (11),-
      - (a) in clause (i), for sub-clause (b) and the proviso the following shall be substituted, namely:—
        - "(b) every seat shall be placed along the vehicle facing each other and there shall be a clear space of not less than fifty inches between the backs of facing seats:

Provided that a hard rail shall be fixed at the end of each seat in such a manner that the passenger readily grasp it when the vehicle is negotiating a corner and shall extend to the whole width of the seat.";

- (b) clause (v) shall be omitted;
- (4) for sub-rule (13), the following shall be substituted, namely:—
  - "(13)(a) Every entrance and exit of every auto-tempo shall be so constructed that—
    - (i) the height measured from the lowest level of such entrance and exit shall not be less than three feet six inches and the door with automatic lock shall be fitted to cover the lower part of such entrance and exit to a height equal to the level of side guards;
    - (ii) the width shall not be less than eighteen inches in any level;
    - (iii) a grab rail shall be fitted to every entrance and exit to assist passengers in boarding or alighting from the vehicle.";
- (5) in sub-rule (16), clause (i)(b) shall be omitted.".
