Whereas Kitab Ali, son of Md. Nayetullah of village Jangalia, P.S. Pakundia, district Mymensingh, is wanted in connection with Special Powers Act Case No. 106/75, G.R. Case No. 244(2)75, Pakundia P.S. Case No. 8(2)75 under section 5 of Explosive Substances Act read with section 26 of the Special Powers Act XIV of 1974;

And whereas I have reason to believe that accused Kitab Ali is absconding and concealing himself so that he cannot be arrested and produced before this Court for his trial;

Now, therefore, in exercise of the powers vested in me under sub-section (6) of section 27 of the Special Powers Act XIV of 1974 read with sub-section amendment, I, A. F. M. Hafezullah Bhuyan, Additional Sessions Judge, 2nd Court and Special Tribunal Judge, Mymensingh, do hereby direct the aforesaid accused person to appear before me in my Court within 35 (thirty-five) days from the date of its publication in the *Official Gazette* and if he fails to comply with the above direction, he would be tried *in absentia*.
