PROCLAMATION

Whereas it has been made to appear to this court that the undermentioned accused is required to appear before the court of Additional Sessions Judge, 1st Court, Tangail, for trial in connection with the case noted below;

And whereas this court has reason to believe that the said accused persons are absconding and concealing themselves to avoid arrest and appearance before abovementioned court for the purpose of their trial;

Now, therefore, in exercise of the powers conferred by sub-section (6) of section 37 of Special Powers Act XIV/79, I do hereby direct the undermentioned accused persons to appear before this court on 31st day of December, 1981 at 10 a.m. or within 30 days from the date of publication of this order in the official Gazette whichever is later, failing which the accused shall be tried *in absentia*:

Accused: (1) Abbas Ali, son of late Hossain Ali of Taratia, P.S. and Dist. Tangail.

(2) Nazrul Islam, son of Darog Ali of Baui Khola, P.S. Basail, Dist. Tangail.
