In the aforesaid Rules, for rule 19A, the following shall be substituted, namely :-

"19A. Opium received from India in July 1981, shall be sold by the retail vendors at the retail price of Taka 1,612.82 (Taka one thousand six hundred and twelve and poisha eighty-two) only per seer and Taka 20.16 (Taka twenty and poisha sixteen) only per tola".
