Dhaka, the 1st November, 1983

No. S.R.O. 418-L/83/S-XI/3R-10/83/105.—In exercise of the powers conferred by section 146 of the Paurashava Ordinance, 1977 (XXVI of 1977), the Government is pleased to make the following further amendments in the Paurashava (Election) Rules, 1977, namely:—

In the aforesaid Rules,-

(i) in rule 2, for clause (f) the following shall be ssubstituted, namely :-

"(f) "electoral roll" means an electoral roll prepared under the Electoral Rolls Ordinance, 1982 (LXI of 1982), and shall be deemed to be the electoral roll for a ward under section 22 of the Ordinance,";

- (ii) in rule 3, in sub-rule (1), for the words "Subdivisional Officer" wherever occurring the words "Subdivisional Election Officer" shall be substituted;
- (iii) in rule 4, for sub-rule (1), the following shall be substituted, namely :-
 - "(1) For the purpose of an election, the Election Commission shall, from amongst the officers of the Government or a local authority, appoint a Returning Officer for each Paurashava:

Provided that the same person may be appointed as Returning, Officer for two or more Paurashavas"; and

(iv) in rule 11, in sub-rule (1), for the words "two hundred" and "five hundred" the words "one thousand" and "two thousand" shall, respectively, be substituted.

OFFICE OF THE CHAIRMAN SUMMARY MARTIAL LAW COURT NO. 17, NOAKHALI

PROCLAMATION

Martial Law Case GR No. 74/83

Whereas it has been made to appear to me that the accused Abdul Quyum, son of late Haji Noor Mia of Nazarpur at present 55 No. Pathantuli Road, Nazirpul, P.S. Doublemoorring, Dist. Chittagong, is required for the purpose of trial in the Summary Martial Law Court No. 17, Noakhali;

And whereas the Court has reason to believe that the said accused Abdul Quyum in the case abovementioned be absconding or concealing himself to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of the powers conferred by Regulation 2(11) of the Martial Law Regulation No. I of 1982, this Summary Martial Law Court No 17, Noakhali, do hereby direct the aforesaid accused to appear in this Court at 0900 hours on 15th November 1983 in the GR Case No. 74/83, failing which he will be tried in absentia and his properties, both movable and immovable, may be forfeited to the Government.
