No. S.R.O. 422-L/83/809/Cus.—In exercise of the powers conferred by clause (b) of section 21 of the Customs Act, 1969 (IV of 1969), and sub-section (2) of section 4 of Sales Tax Ordinance, 1982 (XVIII of 1982), the Board is pleased to authorise delivery of the raw materials required for the manufacture of Steel Reeds and Wire Healds, namely, Cotton Reed Wire (8SWG and lower), Cotton Tanning pitch, Wooden Reed Ribs, Heald Wire, Tin and Lead ingot, Soldering compound, Mail eyes; Adjustable Steel Plates only by recognised industry and imported up to the annual entitlement recorded in their pass book at 10% customs duty and 10% sales tax, respectively.
