# TRANSFER OF SHARES OF TEXTILE MILLS TO THEIR FORMER BANGLADESHI SHAREHOLDERS

Whereas some persons entitled to receive payment of compensation under Article 9 of P.O. 27 of 1972, did not apply for buying their shares within 21 days of publication of notice No. IND. DIV(IC)-TTM-1/82, dated 26th September, 1982.

AND WHEREAS some such persons applied for shares but did not deposit the share price or execute the Instrument of Transfer of Shares.

AND WHEREAS the Government considers it desirable to extend the time for making applications for such sales.

Therefore, the Government is pleased to allow seven days time, from the date of publication of this notice, to enable persons entitled to received compensation as above to apply for and buy shares, deposit the share price and execute the Instruments of Transfer of shares; and that if such persons fail to apply within the extended time, the Government will have no obligation to entertain any application or claim for purchase of shares by former Bangladeshi Shareholders in Textile Mills mentioned in the aforesaid Notice, dated 26th September, 1982.

Former Bangladeshi Shareholders who have not yet applied are requested to apply in the prescribed form to the Joint Secretary-in-charge, Implementation Cell (Textiles), Industries Division, Shilpa Bhaban, Dhaka and those who have not deposited share money/executed the transfer Instruments are advised to contact the Chairman of the concerned Interim Boards within the aforesaid time.
