Dhaka, the 26th December, 1982

No. S.R.O. 433-L/82.-The following draft of certain further amendment in the Income-tax Rules, which the National Board of Revenue proposes to make in exercise of the powers conferred by section 59 of the Income-tax Act, 1922 (XI of 1922), is hereby published as required by sub-section (4) of that section, for the information of all persons likely to be affected thereby, and notice is hereby given that the said draft will be taken into consideration on or after the 26th January, 1983. Any objection or suggestion which may be received from any person in respect of the said draft before the date specified will be considered by the National Board of Revenue.

Draft amendment

In the aforesaid Rules, after rule 49B, the following new rule shall be inserted, namely :-

"49C. Every airline shall, for the purpose of making a deduction of tax from any travel agent under sub-section (3BB) of section 18, deduct or collect from such travel gent an amount calculated at the rate of 2 per cent of the commission payable or collectable on the sale of ticket or on receipt for carrying of Cargo:

Provided that any deduction or collection made by an airline as aforesaid shall be deemed to be an advance payment of tax made by the travel agent concerned".
