NOTIFICATION

Dhaka, the 20th November, 1983

No. SRO-452-L/83/MER (R.F.) 22/83-278.—In pursuance of the Proclamation of the 24th day of March, 1982, and in exercise of all powers enabling him in that behalf, the Chief Martial Law Administrator is pleased to make the following further amendments in the Senior Services Pool Order, 1979, namely:—

- a. In the aforesaid Order, in paragraph 4, for sub-paragraph (b), the following shall be substituted, namely:

“(b) the Government may up to the 31st December, 1983 encadre as Pool officer any member of any of the erstwhile regularly constituted Class I Civil Services or any defence service officer absorbed in any of the regularly constituted Bangladesh Civil Service cadre or subcadre; if he is otherwise found fit for such encadrement, without consultation with the Public Service Commission and without restriction as to age or length of service. An order of such encadrement shall stand cancelled if the person concerned does not assume charge of the Pool post to which he is appointed within the date mentioned in this sub-paragraph.”

The above amendment shall be deemed to have taken effect on the 1st day of March, 1979.

NOTIFICATION

Dhaka, the 20th November 1983

No. S.R.O. 453-L/83.—In exercise of the powers conferred by section 57 and section 77 of the Patents and Designs Act, 1911 (II of 1911), the Government is pleased to make the following further amendments in the Patents and Designs Rules, 1933, the same having been previously published as required by subsection (2) of the last named section, namely:—

In the aforesaid Rules,—

- (1) in rule 43, for the full-stop at the end a colon shall be *substituted* and thereafter the following proviso shall be *added*, namely:—

“Provided that where, before or within three months after the expiration of the said period of six months, a request is made to the Controller for an extension of time, the application shall, on payment of the prescribed fee, be continued for any period so requested not exceeding in all three months from the expiration of the said period of six months.”;

- (2) in the First Schedule, after the Num^o. of entry 28 in the first column and the entries relating thereto in the second, third and fourth columns, the following new entries shall be *inserted*, namely:—

“28A. On request for extension of time 4 50.00”; and under rule 43.

- (3) in the Second Schedule,—

- (a) in the second column, in the entries against Form No. 4 in the first column, for the word, figure and letter “or 38A” the comma, figures, letter and word “38A or 43” shall be *substituted*; and
(b) for Form 4, the following shall be *substituted*, namely:—
