

NOTIFICATION

Dhaka, the 7th December, 1983

No. S. R. O. 468-L/83.—In pursuance of the Proclamation of the 24th March, 1982, and in exercise of all powers enabling him in that behalf, the Chief Martial Law Administrator is pleased to make the following rules, namely:—

THE TELECOMMUNICATION OFFICER RECRUITMENT RULES, 1983

- 1. Short title.—These rules may be called the Tele-Communication Officer Recruitment Rules, 1983.
- Definitions.—In these rules, unless there is anything repugnant in the subject or context,—
 - (a) "appointing authority" means the Government and includes any
 officer authorised by the Government to make appointment to the
 post;
 - (b) "Commission" means the Bangladesh Public Service Commission;
 - (c) "probationers" means a person appointed on probation to the post;
 - (d) "requisite qualification", in relation to the post, means the qualification laid down in the Schedule;
 - (e) "Schedule" means the Schedule annexed to these rules; and
 - (f) "post" means the post specified in the Schedule.

- 3. Procedure for recruitment.—(1) Subject to the provisions of the Schedule, appointment to the post shall be made-
 - (a) by direct recruitment; or
 - (b) by promotion; or
 - (c) by transfer on depuation.
- (2) No person shall be appointed to the post unless he has the requisite qualification, and, in the case of direct recruitment, he is within the age limit laid down in the Schedule.
- 4. Appointment by direct recruitment.—(1) No appointment to the post by direct recruitment shall be made except on the recommendation of the Commission.
- (2) No person shall be eligible for appointment to the post by direct recruitment, if he-
 - (a) is not a citizen of Bangladesh or a permanent resident of, or domiciled in, Bangladesh; or
 - (b) is married to, or has entered into a promise of marriage with, a person who is not a citizen of Bangladesh.
 - (3) No appointment to the post by direct recruitment shall be made until-
 - (a) the person recommended for appointment is certified by a Medical Board set up for the purpose by the Director-General of Health Services that he is medically fit for such appointment and that he does not suffer from any such organic defect as is likely to interfere with the discharge of the duties of the post; and
 - (b) the antecedents of the person recommended have been verified through appropriate agencies and found to be such as do not render him unfit for appointment to the service of the Republic.
 - (4) No person shall be recommended for appointment to the post unless-
 - (a) he applied in such form, accompained by such fee and before such date, as was notified by the Commission while inviting applications for the post; and
 - (b) in the case of a person already in Government service or in the service of a local authority, he applied through his official superior.
- 5. Appointment by promotion.—(1) Subject to the approval of the Commission, appointment by promotion to the post shall be made on the recommendation of a Selection Board constituted by the Government in this behalf.
- (2) A person shall not be eligible for appointment by promotion to the post if he has unsatisfactory records of service.

- Probation.—(1) Persons selected for appointment to the post against a substantive vacancy shall be appointed on probation—
 - (a) in the case of direct recruitment, for a period of two years from the date of substantive appointment; and
 - (b) in the case of promotion, for a period of one year from the date of such appointment:

Provided that the appointing authority may, for reasons to be recorded in writing, extend the period of probation by a period or periods so that the extended period or periods does not exceed two years in the aggregate.

- (2) Where, during the period of probation of a probationer the appointing authority is of opinion that his conduct and work is not satisfactory, or that he is not likely to become efficient it may, before the expiry of that period,—
 - (a) in the case of direct recruitment, terminate his service; and
 - (b) in the case of promotion, revert him to the post from which he was promoted.
- (3) After the completion of the period of probation including the extended period, if any, the appointing authority,—
 - (a) if it is satisfied that the conduct and work of the probationer during his period of probation has been satisfactory, shall, subject to the provision of sub-rule (4), confirm him, and
 - (b) if it is of opinion that the conduct and work of the probationer during that period was not satisfactory, may—
 - (i) in the case of direct recruitment, terminate his service; and
 - (ii) in the case of promotion, revert him to the post from which he was promoted.
- (4) A probationer shall not be confirmed in the post until he has passed such examination and undergone such training as the Government may, from time to time, prescribe by order.
