No. S.R.O. 495-L/83/S-X/3C-8/82.—Whereas the Government has, after considering the report of the Deputy Commissioner, Tangail, forwarded through the Divisional Commissioner, Dhaka, in respect of extension of the limits of Tangail Paurashava to the urban areas specified in the schedule below, finally decided under rule 4 of the Declaration and Alterations of Municipalities Rules, 1978 to extend the limits of the Tangail Paurashava to the said areas ;

## NOTIFICATION

Dhaka, the 28th December 1983

**No. S.R.O. 497-L/83.**—In exercise of the powers conferred by Article 17 of the Bangladesh Passport Order, 1973 (P.O. 9 of 1973), the Government is pleased to make the following further amendments in the Bangladesh Passport Rules, 1974, namely:—

In the aforesaid Rules,—

- (1) in rule 4, for sub-rule (2), the following shall be substituted, namely:—

“(2) An application for the issue of a passport or travel document shall be required to be attested by any one of the following:—

- (a) a Member of Parliament;
- (b) a Gazetted officer of the Government;
- (c) a Professor, Associate Professor, Assistant Professor or Lecturer of a University;
- (d) the Mayor, Deputy Mayor or Commissioner of a Municipal Corporation;
- (e) the Chairman of a Paurashava;
- (f) the Chairman of a Upazila Parishad;
- (g) the Chairman of a Union Parishad;
- (h) the Principal of a private college;
- (i) the Head Master of a private high school;
- (j) the Editor of a daily newspaper;
- (k) an officer of a local authority drawing pay in the New National Pay Scale of Grade VII or above”;

- (2) in rule 6,—

- (i) for sub-rule (2), the following shall be substituted, namely:—

“(2) In the case of a surety bond, the applicant for a passport shall furnish a personal undertaking on a non-judicial stamp paper of the value of taka two duly attested by the person attesting the application for passport under sub-rule (2) of rule 4.”;

- (ii) in sub-rule (3),—

- (a) in clause (h), the word “and” at the end shall be omitted;
- (b) in clause (i), for the full-stop at the end a semi-colon and word “; and” shall be substituted; and

(c) after clause (i), the following new clause shall be added, namely:—

“(j) an income tax payee.”; and

(3) for Schedule III, the following shall be substituted, namely:—

“SCHEDULE III

**SURETY BOND**

**(Personal undertaking)**

I, the undersigned, a Bangladeshi national, solemnly declare that I am an applicant/my ward is an applicant for Bangladesh passport, the particulars of whom are given below and also in the declaration form, and I hereby guarantee and undertake to pay the repatriation cost to the Government in the event of my/my ward's repatriation to Bangladesh from abroad on the ground of being destitute, failing which I will be liable for legal action.

I further declare that in the event of my death/being destitute, repatriation costs shall be recoverable from my legal heirs.

NOTIFICATION

REFERENCE : MLTR Case No. 143/83 (Boda P.S. Case No. 1, dated 1-5-1983)  
under section 18 MLR State versus Hashem Ali

and

MLTR Case No. 162/83 (Pirgonj P.S. Case No. 7, dated 28-8-1983)

under section 18 MLR State versus Bishu Mohammad.

Whereas it has been made to appear to me that the accused persons specified in the schedule below, hereinafter referred to as the said accused persons are required for the purpose of trial in Summary Martial Law Court No. 10, Rangpur-Dinajpur;

And whereas the court has reason to believe that the said accused persons are absconding or concealing themselves to avoid appearance or arrest for the said purpose;

Now, therefore, in exercise of power conferred by regulation 2(11) of the Martial Law Regulation No. 1 of 1982, this Summary Martial Law Court No. 10, Rangpur-Dinajpur hereby directs the said accused persons to appear in this court at 10 a.m. on or before 9th January 1984 and 16th January 1984 in MLTR Case No. 143/83 and 162/83, failing which they will be tried *in absentia* and their properties, both movable and immovable, may be forfeited to the Government:
