# THE INSTITUTE OF CHARTERED ACCOUNTANTS OF BANGLADESH (ICAB) NOTIFICATION

Date: 12 March 2025

**No. ICAB/ENF/2025/101/01(G.N):** In exercise of power conferred by clause (1) of Article 28 of the Bangladesh Chartered Accountants Order 1973 (P.O. No. 2 of 1973), the following amendments and additions to the Institute of Chartered Accountants of Bangladesh Bye-laws, 1973 (as amended upto 31 August 2023) are hereby given to insert in the existing bye-laws and to publish the same.

#### (1) Amendment to Bye Law 19

The following clause (4) shall be inserted in the Bye-law 19 of ICAB Bye-laws 1973 (as amended upto 31 August 2023);

"(4) The Election Commission (EC) of ICAB will organize Town Hall meeting in a Hybrid mode (Physical and Online) where the candidates will deliver speeches before election for which he/she will be allowed such time as determined by the Election Commission, which shall not exceed five minutes, to introduce himself/herself and present his/her contribution to ICAB till now. An audio visual of the candidates' speeches will be made available on ICAB website up to the time of Election."

#### (2) Amendment to Bye Law 29

- "(1) The election under these Bye-laws shall be by secret ballot at polling stations set up in Regional constituencies for that purpose and/or using Online Voting facility, whichever is applicable, depending on the location of the member.
- (2) The Optical Counting System (OCS) may be followed for counting the votes."

#### (3) Amendment to Bye Law 18

- (a) The words 'ten years' mentioned in bye-law 18 shall be replaced by the words '05 (five) years'.
- (b) The following Proviso and Further Proviso shall be added in the Bye-law 18:

"Provided that a member who has been elected as a Council member for 03 (three) terms and a member who has been already elected as the President of ICAB shall not be eligible to contest in ICAB election."

"Further Provided that a member of the Institute, being an employee of the same shall not be eligible to seek election to the Council and any Regional Constituencies, nor shall the Council co-opt any officer or employee of the Institute to the Council."
